In addition to above, a per extant rule, you have to submit 5% of the accepted value i.e Rs.12746/- towards performance guarantee (PG) normally within 30 days of issue of acceptance letter i.e. up to 19.03.2017 before signing the agreement and the same should be valid upto 60 (sixty) days of expiry of the contract period / maintenance period (if any extension of time for submission of PG beyond 30 days and upto 60 days from the date of issue of LOA i.e. upto 19.04.2017 may be given by the authority who is competent to sign the contract agreement. However, a penal interest of 15 % per annum shall be charged for the delay beyond 30 days i.e. from 31<sup>st</sup> day after the date of issue of LOA. In case you fail to submit the requisite PG even after 60 days from the date of issue of LOA i.e. upto 20.04.17 the contract shall be terminated duly forfeiting the full amount of EMD and other dues, if payable against this contract and you shall be debarred from participating in re-tender for this contract.
